The applicant's business/visiting card.7. Two photographs.8. Passport should bear applicant's signature as on the application form.
2.	Conference Visa	<ol style="list-style-type: none">1. Letter of the local company/institution giving brief profile of the company/institution, identifying the applicant, sponsoring him and specifying the purpose of the visit.2. A letter of invitation from the conference organizer. Where relevant, the consular officer may also require proof of approval of the Indian authorities for holding the conference.3. Confirmed return tickets.4. Two photographs.5. Passport should bear applicant's signature as on the application form.
3.	Diplomatic Visa/ Official Visa	<ol style="list-style-type: none">1. Note Verbale from Ministry of Foreign Affairs.2. Two photographs.3. Passport should bear applicant's signature as on the application form.4. Copy of air passage booking.

4.	<p>Employment Visa</p>	<ol style="list-style-type: none"> 1. Copy of the employment contract from the company/organization in India. 2. Bank statement in the name of applicant or an undertaking from parent/local guardian. 3. Letter of the local Sudanese Company sponsoring him, giving brief profile of the company and identifying the applicant. 4. Two photographs. 5. Passport should bear applicant's signature as on the application form.
5.	<p>Entry Visa</p> <p>[not covered by other type of visas viz. professional work, meetings, study tours, sport teams or longer stay]</p>	<ol style="list-style-type: none"> 1 Letter of the local Sudanese Company sponsoring him giving brief profile of the company and identifying the applicant. 2. Supporting evidence is required from the inviting organization in India. 3. Bank statement in the name of applicant or an undertaking alongwith bank statement from parent/local guardian. 4. Two photographs. 5. Passport should bear applicant's signature as on the application form.
6.	<p>Journalist Visa</p>	<ol style="list-style-type: none"> 1 Only for professional journalists, media support crew and photographers. Letter of the local Sudanese Company sponsoring him giving brief profile of the company and identifying the applicant. 2. Supporting evidence is required from the inviting organization in India. 3. Bank statement in the name of applicant or an Affidavit alongwith bank statement of the sponsor. 4. Two photographs. 5. Passport should bear applicant's signature as on the application form.

7.	Medical Visa/ Medical Attendant Visa	<ol style="list-style-type: none"> 1. Preliminary medical advice from local Sudanese Doctor/Hospital 2. Reference Letter from a reputed/recognized specialized hospital/ treatment center identifying the applicant. 3. Bank statement in the name of applicant or an Affidavit alongwith bank statement of the sponsor. 4. Two photographs. 5. Passport should bear applicant's signature as on the application form. <p>[Medical Attendant Visa is granted to the spouse/children or those who are blood relatives of the patient]</p>
8.	Research Visa	<ol style="list-style-type: none"> 1. Eligibility/Admission Letter from a recognized educational institution in India. (Original and photocopy) 2. A detailed synopsis of the research project, countersigned by the sponsoring institution in India 3. Degree Certificates (Original and photocopy). 4. Bank statement in the name of applicant or an Affidavit alongwith bank statement of the sponsor. 5. Two photographs. 6. Passport should bear applicant's signature as on the application form.
9.	Student Visa	<ol style="list-style-type: none"> 1. Eligibility/Admission Letter from a recognized educational institution in India. (Original and photocopy). 2. Sudanese School Mark list duly attested by Ministry of Foreign Affairs (Original and photocopy). 3. An Affidavit alongwith bank statement of the sponsor. 4. Two photographs. 5. Passport should bear applicant's signature as on the application form.
	Student Visa (for students already studying in India and applying for visas for going back after completion of leave	<ol style="list-style-type: none"> 1. Certificate of the Educational Institute where studying. 2. Residential permit/Exit permit issued by the District Police in India (Original and Photocopy). 3. College Identity card. 4. Two photographs. 5. Passport should bear applicant's signature as on the application form.

10.	Tourist Visa	<ol style="list-style-type: none">1. Letter from Employer/Company identifying the applicant and specifying the purpose of visit and whether the applicant or the Employer/Company will be responsible for the applicant.2. Bank statement in the name of applicant.3. Confirmed return tickets.4. Two photographs.5. Passport should bear applicant's signature as on the application form.
11.	Transit Visa	<ol style="list-style-type: none">1. Confirmed Air tickets.2. Visas for country(ies) of destination.3. Two photographs.4. Passport should bear applicant's signature as on the application form.
